

## Parent/Guardian Extracurricular Transportation Waiver

If your student (or you, if you are a student age 18 or older) plans to participate in extracurricular activities, please complete and sign the following form for each activity and return it to student's coach or advisor.

I understand that in certain circumstances, Independent School District No. 81, Comfrey, may not provide transportation to events, practices, or other activities related to the extra-curricular activity identified above. I understand and agree that in such circumstances where Independent School District No. 81 is not providing transportation, it is my sole responsibility to arrange for my student's transportation to and from such extra-curricular activities and events. In addition to not providing transportation in those situations, Independent School District No. 81 is not supervising student transportation to any extent or in any capacity.

I understand that Independent School District No. 81 is not liable for any injury or damage when students are provided transportation by a vehicle driven by themselves or others. I understand that students and other parents may arrange for transportation to and from extra-curricular activities and events, but that Independent School District No. 81 does not have any involvement, nor does it make any statements or assurances regarding such transportation. I agree that no person driving my student (or me, if you are a student age 18 or older) to or from an extra-curricular activity or event for which the School District is not providing transportation shall be considered an agent or employee of the School District, in any respect or for any purpose, while driving my student (or me, if you are a student age 18 or older).

I understand that Independent School District No. 81 offers students the opportunity to participate in school sponsored extracurricular activities and that such participation is completely voluntary. I recognize and understand that motor vehicle transportation involves inherent risks, including but not limited to the risks of damage to property, physical injury, or death. In consideration for the District offering the extra-curricular program identified above, and knowing the inherent risks and dangers that are involved, I agree for myself and on behalf of my student, not to assert against Independent School District No. 81, its School Board members, officers, agents, employees, insurers, representatives, and volunteers in any court of law, any claim or claims whether known or unknown, that arise as a result of my student's transportation to or from activities related to the extracurricular activity identified above, including but not limited to the following situations:

1. Where I transport my student or other students;
2. Where I give permission to another person to transport my student;
3. Where my student transports himself or herself; or
4. Where my student transports other students to or from an extra-curricular event or activity;
5. Where I or a group of parents or other individuals contract or arrange for transportation and the school does not directly contract for such transportation.
