## **Essential Functions:**

- Transport mail from post office to appropriate sites.
- Transport bank deposits to bank.
- Post all outgoing mail appropriately, sorts, and transports to post office.
- Transport meals to ALC.
- Locate and tag all new fixed assets in the system and reports discrepancies to Business Manager and Superintendent.
- Other duties as assigned.

# **Physical Demands of the Position:**

The driver has a moderately strenuous job. The Driver must sit for periods of time and requires intense concentration, particularly in poor driving conditions. While performing the duties of this

job, the employee is frequently required to sit; use hands to finger, handle, or feel; use foot controls to drive; reach with hands and arms; climb; bend, stoop, and kneel; and talk or hear. The employee must be physically able to perform and demonstrate to having the ability be able to lift at least 20 lbs and bend regularly. Specific vision abilities required by this job include close vision, distance vision, night/dusk vision, color vision, and peripheral vision.

# **Working Conditions:**

The unavoidable, externally imposed conditions under which the work must be performed and which create hardship for the incumbent include the frequency and duration of occurrence of physical demands, environmental conditions, demands on one's senses and mental demands. The Driver must work in all different weather conditions including extreme cold and extreme heat.
