

2019-2023 Strategic Plan Chairs Josh Boyer Greg Lucas Kyle LeMieux Congratulations to all high school administrators on a highly successful start to the 2021-22 school year and a very exciting and safe WIAA fall sport season. Somehow, through all the hurdles that were thrown at all of us, we were once again able to navigate these challenges and provide education-based athletics for student-athletes throughout our Wisconsin high schools.



Following this success, especially during this holiday time of year, a good opportunity presents itself for Athletic Administrators to interact and provide beneficial information to their school boards or governing bodies. This is done in an effort to demonstrate the value and importance education-based athletics plays in the overall education of students. Working with your school boards also contributes to the overall understanding that local school boards have in making sure that athletics remain a vital part of high schools throughout the State. It also sets up an Athletic Administrator for positive discussions with their school board during the remainder of the year, especially if more difficult topics and issues develop.

A school board meeting can be a new and different playing field for Athletic Administrators. It is important to realize and understand that school board members can ultimately make better decisions when Athletic Directors and Coaches know the lay of the land. One simple example is to update your local school board regarding participation numbers from the fall sports season. In addition, ensuring school boards that all students have an equal chance to enjoy the benefits of extracurricular activities as this is a goal shared by school boards and proponents of high school athletics.

John Ashley, Executive Director of the Wisconsin Association of School Boards, advises Athletic Administrators to utilize the following ideas:

- Work with your district administrator if you believe an item needs to be on the agenda for a school board meeting.
- Don't assume your school board already understands the issues at play.
- It's OK when you don't have an answer say you'll research it and get back to the board.
- Be sure to give your board the opportunity to acknowledge and honor participating students.

Communicating legislative issues to school boards is another way Athletic Administrators can work together to advance shared goals. Promulgating a policy on issues like sportsmanship, school codes or coaches reviews with your school board can also be very beneficial. The development or updating of policies and procedures is always a helpful tool for Athletic Administrators to assist school board members with an improved understanding of actual operations of the Athletic Department.

Developing a relationship with your School Board will go a long way to allow Athletic Administrators communication opportunities as the year progresses that allow for key issues to be thoroughly reviewed. When you understand the role of School Boards in athletics and you can speak their language, you'll have a clearer understanding of where your essential work fits in the school district's overall vision.
