- PPE is available for direct support student services
- Routines of hygiene education and practices
- Daily and frequent cleaning of high touch surfaces
- Building Level COVID-19 program coordinator to monitor situations
- Monitor and exclude for illness
- All positive COVID-19 cases will be reported to MDH

Operations

- Social and Physical Distancing
 - During in-person learning we will create as much space between students as is feasible with a goal of at least 3 feet.
- Facility Use
 - Events and activities will follow the most upto-date Southland "Safe Learning Plan" requirements



Operations Continued...

- Face Coverings
 - Face coverings are available for students and staff on school property
- Cleaning and Disinfecting
 - Increased frequency of daily disinfecting
 - Staggered use of communal spaces to allow for disinfecting
 - Sharing of objects between staff/students will be minimized
 - Cleaning supplies and hand sanitizer will be available in all classrooms



Operations Continued...

- Cleaning and Disinfecting Con't...
 - Hygiene education will be delivered to all students and staff on a continual basis
 - Signage to remind and reinforce physical distancing and hand washing will be displayed throughout the building
- Custodian schedules will be modified to allow high touch surfaces to be cleaned frequently
- The highest air quality standards will be maintained with increase circulation and bipolar ionization



Health and Safety

- COVID-19 affects different people in different ways
- Infected people have a wide range of symptoms—from mild to severe
- CDC does not currently recommend universal symptom screening for students at school
 - Parents will be the fundamental part of the student screening process

- More common symptoms: Fever of 100.4 or higher, new loss of taste/smell, difficulty breathing, new or worsening cough
- Less common symptoms: Sore throat, nausea, vomiting, diarrhea, chills, muscle pain, extreme fatigue, new severe head ache, new nasal congestion, runny nose



Health and Safety Continued...

- Students found to be ill at school with one or more common symptom or two or more less common symptoms will be sent home
 - Students that have symptoms will be in an isolation room until they can be picked up by a parent or caregiver.
 - The isolation room is not intended to hold students all day—It is a waiting area isolated from non-symptomatic students.

- It is absolutely imperative that your phone numbers are up-to-date as well as the emergency contact phone numbers.
- Make sure you have a BACK UP PLAN for your student(s) in the event they need to be sent home by the school nurse or other delegate.



Parent/Student Expectations

- Parents are expected to conduct a DAILY screening of their students
- It is critical that parents, students, and staff comply with the daily health screening check list on a daily basis
 - Screening measures won't prevent all transmission, but the goal is to minimize transmission as much as possible



Daily Home Screening for Students

Parents: Please complete this short check each morning and report your child's information [INSERT YOUR SCHOOL REPORTING INSTRUCTIONS] in the morning before your child leaves for school.

SECTION 1: Symptoms

If your child has any of the following symptoms, that indicates a possible illness that may decrease the student's ability to learn and also put them at risk for spreading illness to others. Please check your child for these symptoms:

| Temperature 100.4 degrees Fahrenheit or higher when taken by mouth |

| New uncontrolled cough that causes difficulty breathing (for students with chronic allergic/asthmatic cough, a change in their cough from baseline) |
| Diarrhea, vomiting, or abdominal pain |
| New onset of severe headache, especially with a fever |

SECTION 2: Close Contact/Potential Exposure

| | Had close contact (within 6 feet of an infected person for at least 15 minutes) with a person with confirmed COVID-19 |

Handling a Positive COVID-19 Case

If You Test Positive For COVID:

- Stay home and Isolate for 5 days
- Get tested with an At Home Antigen Test on Day 5 If negative (send proof to school) You
 may return to school WITH a mask through Day 10
- If positive you must remain out of school through Day 10 and can return on Day 11.
- If you still have a fever on Day 5 you must stay out through Day 10 and can return on Day 11.





Early Childhood Programming

- Southland's Early Childhood Center will continue with its regular programming
 - Increased physical distancing will be implemented when feasible.
 - Wearing face coverings for Early Childhood students and staff is recommended
- Pre-School: Monday, Wednesday, Friday
- Play and Learn: Tuesday, Thursday



School-Age Care

- Southland's School-Age Care will be available for all qualifying students
 - Additional physical distancing and grouping measures will be implemented
 - Wearing face coverings for SAC students is recommended



Special Education Services

- Southland's special education department and our partnership with SMEC will continue to provide educational services for students with disabilities by meeting their unique needs in alignment with state and local regulations.
- Special education staff will communicate with families to reconvene IEP teams, when necessary, to discuss the most appropriate placement and method of providing services.
- Access to education may need to be reconfigured to meet physical distancing guidelines while meeting individual needs.
- Caseloads may need to be redesigned to provide access to individual learning to the IEP.



Transportation

- In-Person Model
 - Vehicles will be disinfected after daily
 - Students may have assigned seats



Food Service

- Cafeteria tables and serving areas will be disinfected between lunch periods.
- All students and staff will wash and/or sanitize their hands before and after lunch.



Social Emotional/Mental Health Support

- Based on Southland parent/student/staff survey results, supporting the mental health of students and staff is a top priority
- Training and support will be delivered to all school staff through ongoing in-person trainings, online courses, and information resources.
- Southland's school social worker will coordinate mental health supports for students by utilizing the resources available from national, state, and local mental health support organizations.



Southland COVID-19 Positive Case Threshold Levels

- Level 1: 0-24 (0-4%) simultaneous positive COVID-19 cases
 - Masking is RECOMMENDED in addition to all other mitigation strategies described in the Southland Safe Learning Plan

- Level 2: 25+ (5%+) simultaneous positive COVID-19 cases
 - Masking for all people in Southland buildings will be REQUIRED in addition to all other mitigation strategies as described in the Southland Safe Learning Plan



Plan-In-Motion

- Southland's Safe Learning Plan is a work-in-progress.
- Our plan will be altered as needed based on updated health information. In addition, the procedures and routines we intend to implement may need to be modified as we navigate the beginning of the school year.
 - In the event we reach 25 simultaneous positive COVID-19 cases we will move to our Level 2 plan and masks will be required.
- The Southland School District is committed to providing a safe learning environment and an exceptional educational experience.
