Student Pledge for Internet & Electronic Device Use

1. I understand and will follow the policies outlined in the iPad Handbook and the Use of Technology Resources Policy while at school, as well as outside the school day. These can be found on our website or in the office.
2. I understand that the purpose of the school district's computer systems and Internet connection is educational. I will limit my usage to educational purposes and respectfully keep all electronic communications.
3. I understand that my use of the school district's computers is a privilege, not a right. My access may be licensed, revoked, limited, or subjected to conditions at any time by the school district as it shall see fit. I also understand that inappropriate behavior may lead to the loss of my right to use the Internet, additional disciplinary actions determined at the building level.
4. I understand I cannot access, upload, download, or distribute violent, obscene, or inappropriate material for any purpose.
5. I will take good care of my device, keeping it charged daily, and use it in ways that are appropriate.
6. I understand that my device, as well as all my documents, files, and school issued accounts are the property of the school district and can be inspected at any time without notice.
7. I will keep food and beverages away from my device since they may cause damage.
8. I will know where my device is at all times, never leaving it unattended or lending it out to other individuals.
9. I will protect my device by only carrying it in the case provided.
10. I will not place decorations (such as stickers, markers, etc.) on my device.
11. I will not disassemble any part of my device or attempt any repairs.
12. I will be responsible for all damage or loss caused by neglect or abuse.
13. I will file a police report in case of theft, vandalism, and fire.
14. I will return the device, case, power cords, and any accessories in good working condition.

I agree with the stipulations outlined in the above documents, including the iPad policy, Procedure, and Information; the Acceptable Use Policy; and the Student Pledge for Electronic Device Use.
