CAFETERIA

Meals Served:

Breakfast meals will be served in the morning and at mid-morning recess. Lunch meals and alternate meals will be served during the lunch period.

Cafeteria rules must be obeyed at all times:

1. Courtesy is expected and required from students.
2. Students will wait their turns in line (i.e. NO CUTTING)
3. Students will dispose of trash in the waste receptacles provided.
4. Students will cooperate with the meal monitors and supervisors on duty.
5. If you forget your ID, you must go to the Office during: Early Morning, or morning recess. No ID's will be given out at lunch.

MEALTIME PROCEDURE

BACKGROUND

- Each student will automatically be assigned a barcode with their student IDs
- Each card will include the student's picture, name and barcode representing his/her unique PIN
- Each student's account is like a personal debit account for purchasing school meals.
- Each student or parent will make deposits to their account by cash or check made payable to Kalani High School

Student eligibility status (e.g., Free, Reduced, or Paid) is confidential and is not identified on the individual student IDs

MAKING DEPOSITS

Deposits can also be made in the cafeteria as follows:

1. Breakfast - Office
2. Mid-Morning Recess - "B" Line
 - Deposits must be exact amount only. No change will be provided
 - Minimum deposit is \$20.00 (Checks are preferred).
 - A student eligible for Free or Reduced meals must deposit money to purchase second meals, healthy snacks, beverages or extra milk. Second meals or extras are charged at full price.
 - Individual account statements are available on request by parents
 - Students or parents may also drop off their deposits at the main office. Deposits made between 8-9:30 AM will be available for use for lunch service.
 - Deposits will not be taken during lunch service

PURCHASING MEALS

Students are required to purchase all school meals and food items with their school ID. If ID is forgotten, student must go to the office to get a temporary ID (good for that date only). A fee will be charged after 3 temporary IDs are made.

Once the bar code is scanned, the purchase price is automatically deducted from the student's account. A student who is eligible for subsidized meals (free) will not

have any money deducted from his/her account for the first breakfast and lunch for the day. If a student purchases a second meal, he/she will be charged at full price regardless of eligibility status. Full prices are listed below:

All second meals (free and reduced) will be charged the full price.

- Borrowing and/or letting out ID cards is not allowed. Students are to purchase their own meals with their own cards to alleviate 2nd meal purchases (students buying for their friends). We do not get monies from the federal government to cover the cost of the 2nd meals; therefore, we need everyone to purchase their own meals. Continued misuse of this policy will result in detention of the student. Charging a meal is not allowed. We do not give lunch loans.

REPLACING A LOST, STOLEN, OR DAMAGED CARD

- If ID is forgotten, student must go to the office to get a temporary ID (good for that date only). A fee will be charged after 3 temporary IDs are made.
- If a student's card is deface and/or unreadable, a replacement card will be issued at the cost of \$10.00. The student is responsible for the \$10.00 fee.
