JOB GOAL: Perform cleaning and maintenance specific to swim pool area to provide pleasant

and safe surroundings for students, staff and general public.

## PERFORMANCE RESPONSIBILITIES:

1. Assure all pools are chemically treated, physically and mechanically cleansed to meet Health Department codes and facility standards for clarity, free chlorine, calcium harness, alkalinity, PH levels, and temperature minimum and maximums.

- 2. Understand practices of operations and preventative maintenance for pumps, suction lines, balance tanks, valves, skimmers, lint traps, flow, pressure, and control switches for each system.
- 3. Test and adjust water chemistry to meet Health Department and facility codes for oxidation and sanitation.
- 4. Maintain and interpret operation and recirculation efficiency of the various filters and pools.
- 5. Check and interpret gauges, flow meters and monitor same for operational efficiency.
- 6. Maintain state required records of operational parameters and procedures.
- 7. Maintain air circulation filtration system.
- 8. Inspect and assure cleanliness and appearance of the whole facility.
- 9. Maintain and sanitize locker rooms, restrooms, showers, staff locker rooms, pool deck, office areas and lobby to eliminate health or accident hazards to all users and staff.
- 10. Inspect and maintain all ancillary hardware (ladders, diving boards, main drain, cover, etc.)
- 11. Practice safe handling of all chemicals.
- 12. Other duties as assigned.

## PHYSICAL REQUIREMENTS:

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

- hearing and speaking to exchange information
- seeing to perform assigned duties
- dexterity of hands and fingers to operate equipment
- ability to bend, crouch, twist, reach, kneel, crawl, and balance during building maintenance activities
- pushing, pulling equipment that exceeds 100 pounds or lifting heavy equipment or supplies (up to 50 pounds)
- climbing stairs/ladders
- walking, standing or sitting for extended periods of time
- operating assigned equipment

- exposure to air contaminants, confined work spaces, dirt, electrical hazards, temperature extremes, noise, toxic materials and vibrations.

Offers of employment will be made contingent upon passing a pre-employment physical, and upon satisfactory evaluation of the results of a criminal background check. Candidates who refuse to submit to testing will be disqualified from the hiring process.

TERMS OF EMPLOYMENT: Salary and work year to be established by the Board of Education.

EVALUATION: Performance of this job will be evaluated annually in accordance with

the provisions of the Board's policy on evaluation of non-certified
