

Importance of Transitioning Customers When an Employee Leaves

Let's face it, employees don't stay at the same company forever. Whether they retire, resign, or leave for other reasons it is very important to put effort into trying to successfully transition their key customers to other staff but realize this is a very big challenge!

Think about your doctor: you are more likely to have loyalty to them than the hospital they work for. Relationships are a critical part of any business, and it is normal and expected that personal relationships that are developed with your customers are stronger than their relationship with your company.

Studies have shown that customers tend to have three major concerns when they hear their main contact at a company is leaving:

- "I'm losing my most important contact with the company". Try to, the best you can, develop a bond between your company and the customer that is so strong it supersedes any one employee.
- "Whoever I get as a replacement won't be as good as the person that is leaving". Try to not only communicate but demonstrate the quality of all of your employees.

• "I'll have to start all over again, I'm losing my history with this company, something will fall through the cracks". Do your best to notify your customers of any turnover promptly and professionally and work hard to make the transition as smooth as possible for that customer.

I had a personal experience recently that directly related to this topic: I had developed a very strong and successful relationship with our corporate banker and had been a very satisfied customer for eight years with that bank. She decided to leave and go to a different bank. As much as I had liked working with her, I realized the value of the eight years of history with that bank and decided it would be best to not switch banks and "start over". I met with the new contacts that replaced her, everything seemed to be going well, and then they dropped the ball on our "automatic" annual renewal of our account and at the same time said things like "with time we will get to know you better". Apparently my eight year successful history with their bank had disappeared and I was "starting over". My thought then, as I told them, was "If I'm going to be treated as a new customer (instead of a customer with a long history) I might as well be a new customer (somewhere else)!

They don't know it yet, but I will soon be moving my account to a different bank and I'll only give you one guess where I'm moving to! I had every intention of staying with our existing bank but their failure to provide a smooth transition for me plus their ignorance of our eight year history resulted in a lost customer. They blew it and are losing a good loyal customer as a result. Try not to make those same mistakes when an employee leaves your company!

LEAD IN WATER JARGON TO KNOW

With the Minnesota Legislation requiring schools to drop lead in water to 5 ppb and share our tests and remediation action the summer of 2024 I thought this information from the EPA may be helpful this month.

A Consumer Tool for Identifying Point of Use (POU) **Drinking Water Filters Certified to Reduce Lead**

POINT OF USE FILTERS

Point of use, or POU, drinking water filters are used to remove impurities from water at the point that it is actually being used. Although there are others, the POU filters covered in this document are those used in filtration systems that are attached directly to water faucets, inserted into refrigerators for water dispensers and ice makers, or inserted into water pitchers and bottles.









How do I know if a POU filter has been certified to reduce lead?

There are several American National Standards Institute (ANSI) accredited third-party certification bodies that evaluate POU drinking water filters for lead reduction. Each has a registered trademark that is used on certified products.

Certification bodies require their mark and a statement indicating testing against NSF/ANSI Standard 53 along with a claim of lead reduction. We recommend that you also look for filters tested against NSF/ANSI Standard 42 for particulate reduction (Class I)*.

The table below provides the certification bodies' approved marks and the text that indicates a filter has been certified for lead reduction capabilities. Some filters can be certified by more than one certification body and have multiple certification marks.

Is certification required for POU drinking water filters?

There is no mandatory federal requirement for the use of POU drinking water filters or for testing or third-party certification under the Safe Drinking Water Act. However, consumers can increase their level of confidence by purchasing filters that have been tested by an accredited third-party certification body or bodies for lead reduction and particulate reduction (Class I) capabilities against both NSF/ANSI Standards 42 and 53.

Withough particulate reduction (Class I) is for aesthetic effects, it is being suggested since some particulates can contain lead.



Certification Marks, Standards Text, and Claims of Reduction on Filter Packaging

Certification marks are detailed in the Table on Page 1. Examples of certification marks, NSF/ANSI Standards 42 and 53 text, and claims of lead reduction and particulate reduction (Class I) as found on product packaging are shown below.



Where are the certification marks and Standards text located?

The certification marks can be found on the filter or on the smallest container in which the filter is packaged. NSF/ANSI Standards 42 and 53 text will be located under or near a certification mark, if lead reduction and particulate reduction (Class I) are not specifically mentioned in the text, information can be found in a table on the packaging. on the performance data sheet located inside the filter packaging or on the manufacturer's website, or in the certifier's online product listing directory (see links in the table on Page 1).

Performance Data Sheet Inside Filter Packaging or on Websites

Claims of lead reduction and particulate reduction (Class I) not included on the filter packaging can typically be found on the performance data sheet located inside the filter box or other packaging (example below), or on the manufacturer's website.

Three Ways Facility Condition Assessments Help You Today

Whether you're managing the facilities for a school district, college campus, municipality, local/state government, healthcare space or hospital, apartment building, warehouse, retail, hotel, the list could go on – you need to fully understand the current state of each building system within your real estate portfolio. The best way to thoroughly gather this information is with an asset inventory that feeds a facility condition assessment.

A facility condition assessment (FCA) is an analysis of a building's condition as it relates to its age, design, construction methods, and systems. Typically conducted by an FCA specialized service provider, they include a review of documentation related to a building's original construction, any renovations, and a physical site walkthrough to ensure accuracy of as-built or as-is condition. They often utilize capture technology to include typical elevations of the building's exterior, site work, parking, roofing, structural systems, plumbing, HVAC, electrical systems, conveyance systems, life safety systems, and any specialized assets or systems.

How to Utilize the Results

When the FCA is complete, you'll receive an in-depth condition report of your building, including photographic evidence of all findings. From building exteriors (roof, envelope, windows, doors) to interior materials (walls, floors, fixtures, ceilings), and mechanical, electrical and plumbing systems used throughout, you'll gain a better understanding each. So how can you best start putting those results to use?

Begin facility and capital planning

The results of your FCA are a great foundation when developing strategic facility planning metrics such as system reliability, uptime, operability, maintainability, total cost of ownership, life cycle costing, energy management, and master facilities planning. Understanding your building's condition gives a measure of the effectiveness of your current capital renewal programs. These metrics help determine the remaining useful life of various components or systems and compares it with full economic life expectancies, given good maintenance practices. These results can help you better plan and prioritize routine or deferred capital renewal, energy savings projects, total replacement costs, maintenance optimization, and more.


Better manage your building's assets

FCAs can also identify all assets, materials, and systems utilized in your building and the current performance state of each, especially those which are near or past their useful life and pose a risk for failure. For example, if stained ceiling tiles are present throughout multiple spaces within a building, further investigation can reveal a host of potential larger problems, such as roofing failure, leaking sprinkler pipes, or uninsulated HVAC equipment.

The results of your FCA can also help you mitigate potential issues and stay ahead of challenging conversations with code officials that frequent buildings by identifying obstructed pathways, unclean mechanical rooms, and unsigned emergency exits.

Address risks in your facility. FCAs can identify risks present throughout both the exterior and interior of your building's footprint and may lower the potential for litigation. Sidewalks, entrances, and exterior walkways that are uneven, damaged, or otherwise in poor condition could enable tripping hazards. Interior spaces that are not ADA compliant can introduce risks for individuals; this is especially important for K-12 schools and healthcare facilities to consider to protect the safety of students and patients.

A good FCA can also help with emergency planning and readiness efforts by verifying emergency annunciation technology, such as public address system, security card readers, and cameras that are operable and in good working condition – helping mitigate further potential risks and ensure rapid response, if a situation would arise.

How to Prepare for Your Next FCA FCAs should be conducted on a regular basis, completed approximately every three years. You may also elect to conduct an FCA for a portion of your overall facility portfolio annually, depending on how many different buildings you manage.

Partnering with a service provider who specializes in FCAs, especially for a given industry or building type, can help ensure accuracy, organization, and thoroughness of the results. A FCA team can be comprised of a stand-alone service provider or a combination of architectural, engineering, and energy efficiency experts, or an asset management firm. Firms with a multi-disciplinary approach and composition of team members with varying areas of expertise are best positioned to deliver the most effective FCA services and provide organizations with the necessary facility data to make strategic decisions.



Your FCA service provider will need to gather information about your building's original construction and any renovations or upgrades that have been performed over its lifespan. Often, an estimate of probable costs associated with potential projects is developed to aid in budgeting and planning.

Be sure to gather all documentation needed for this step, including:

Warranty information, Safety inspection records, Records indicating age of material building systems, such as the roof, chillers, boilers, electrical, etc. All previous FCA reports, Pending proposals or contracts for equipment replacement; A description of future improvements planned; Americans with Disabilities Act

Drawings and specifications, including as-built or construction

Another aspect to consider when selecting a service provider is their level of forward-thinking technology to house and present information covering the facility's construction and renovation history, maintenance, operations and utilities, and FCA findings. Such technology is also helpful for giving facility managers one place to assess their assets, evaluate potential investments, define long-term planning, measure facility performance, and ensure any projects conducted, especially those as a result of findings from a condition assessment, are efficient and achieve the organization's goals.

FCAs are packed with a deeper insight into your facility and can help with capital planning, managing assets, and mitigating potential risks. It's important to remember to schedule an assessment on a regular basis, typically every three years. Consider budgeting this work now versus waiting until your systems begin to fail to schedule your next FCA.



MASMS Legislative Update

2023 Legislative Session Concludes



For the first time in a decade, the legislature and Governor concluded all state government budget work on time, with no need for a special session brushing up against the June 30th fiscal year deadline. Words to describe the DFL Trifecta's work this session range from 'historic and transformational,' to 'unsustainable and bonkers.' The truth is in there somewhere and a lot depends on how the world's economy performs in the months and years to come. 'Aggressive' is the word I like to use to describe the session's pace and resulting legislation. One observer noted that decades can pass with little legislative activity and then in one session decades of activity will transpire.

All told, 75 chapters of new law have been presented to the Governor, including major omnibus budget and policy bills. He signed 74 into law and vetoed one, a bill that would regulate ride share services (Uber and Lyft). The new state budget will grow substantially as the near entirety of the \$27.5 billion available to the legislature for the next 4-years was committed in some way shape or form. Not including a state budget reserve of roughly \$3 billion, they left about \$800 million in cash for another cash-funded Capital Investment bill during the 2024 legislative session. Next November's budget forecast will be interesting to say the least. The legislature returns to this regular session on February 12, 2024.

Education: 'More Money, More...well, we'll see"

Unemployment Insurance –

Minnesota will be a first-in-the-nation experiment for extending UI benefits to non-certified staff. Per the new law, as of May 28, 2023, non-certified staff will be able to apply for UI benefits and DEED, the agency administering UI, we evaluate those applications based on a standard of 'suitable employment.' We all have more questions than answers. The new education bill provides \$135 million in one-time funding that schools can draw down from as their UI bills come in. The mechanics of applying for that and how/when it will be disbursed are not publicly known at this time. Beyond the initial \$135M the new education funding bill also layers in an on-going pot of \$64 million each year as part of special education reimbursements to schools under the assumption that most on-going UI costs will stem from paraprofessionals coded to special education services.

What will the impact be on summer programming? At what rate will non-certified staff utilize UI? What will the actual cost be? How will this change the approach of school districts for staff contracts? Will we see more 11-month contracts emerge? What does this leave for net revenue for wage and benefit increases? These questions and many more are out that and the answers to them will take time to emerge.

Expanded 'Terms and Conditions' for Collective Bargaining

Another labor victory this session was an expansion of the required scope of collective bargaining to include negotiations over, "adult-to-student ratios in classrooms, student testing, and student-to-personnel ratios." I mention this for a few reasons. First and foremost, the culture and vibe of collective bargaining could get extremely confrontational over the next cycle or two. Second, the impact of bargaining over these issues could impact the facility needs of each school district. Fewer students per classroom space, for instance, could require schools to build or lease additional space.

LTFM, bathrooms, lead, opiates and more -

The DFL Trifecta was so focused on student and staff needs that facilities were marginally addressed. Menstrual products must be provided, along with single-use, gender-neutral bathrooms. Lead remediation down to 5 parts per billion is a new mandate, along with making sure opiate antagonists are available at schools. How these are paid for are clear to some degree, menstrual products will generate additional Operating Capital revenue, for instance, but the cost of new bathrooms is a question. Mostly, it appears that schools will be adding some items into Health & Safety or LTFM.

Speaking of LTFM, we will be engaging with MDE this summer and fall on a hoped-for series of conversations around improving LTFM funding for schools. This is a big topic that was not addressed during the session, but more work needs to be done here. Until then, enjoy the summer, we know how fast it goes.

We have had questions on this part of the bill. Here is the operative language for school personnel to study and comply with.

Section 1.

[121A.212] ACCESS TO MENSTRUAL PRODUCTS.

A school district or charter school must provide students with access to menstrual products at no charge. The products must be available to all menstruating students in restrooms regularly used by students in grades 4 to 12 according to a plan developed by the School district. For purposes of this section, "menstrual products" means pads, tampons, or other similar products used in connection with the menstrual cycle.

EFFECTIVE DATE.

This section is effective January 1, 2024.
