Motion by J. Chambers, second by L. Ramson, to add a 5th grade section. Roll call vote. Those voted in favor: J. Chambers, T. Quaintance, L. Ramson, P. Nelson. Those voted against: A. Struffert, C. Patnode. Those absent: B. Bunger. Motion carried.

Motion by A. Struffert, second by J. Chambers, to call a meeting when Kindergarten registration is 159. Motion withdrawn.

Motion by T. Quaintance, second by C. Patnode, once we reach 150 registered Kindergarten students we will call a meeting to discuss and decide adding another section. Roll call vote. Those voted in favor: T. Quaintance, C. Patnode. Those voted against: J. Chambers, L. Ramson, P. Nelson, A. Struffert. Those absent: B. Bunger. Motion failed.

Motion by J. Chambers, second by A. Struffert, to set a meeting on August 13th, 6:30 pm, to asses Kindergarten issue. Motion carried.

Motion by A. Struffert, second by J. Chambers, to approve the Attachment 99 Performance Criteria. Motion carried.

Motion by J. Chambers, second by C. Patnode, to approve the reductions recommended by the Community Ed Council and direct the Superintendent/Community Ed Director and Business Manager to follow their directives.

Heard reports from the Board committees.

Reviewed the first reading of Policy 702 – Unreserved/Undesignated Fund Balance.

The Board reviewed the calendar.
