Sarah Ploeger nominated Jeff Larson as Chairperson. Todd Quaintance seconded the nomination. Motion by Jere Day, second by Sarah Ploeger, to cease nominations. Motion carried. Jeff Larson appointed as Chairperson by white ballot vote, 6:0:1.

Sarah Ploeger nominated Todd Quaintance as Vice-Chairperson. Jere Day seconded the nomination. Todd Quaintance appointed as Vice-Chairperson by white ballot vote, 6:0:1.

Todd Quaintance nominated Sarah Ploeger as Clerk. Aimee Struffert seconded the nomination. Sarah Ploeger appointed as Clerk by white ballot vote, $6: 0: 1$.

Todd Quaintance nominated Jere Day as Treasurer. Sarah Ploeger seconded the nomination. Jere Day declined the nomination as Treasurer. Aimee Struffert nominated Brandon Baker as Treasurer. Bryan Rensenbrink seconded the nomination. Motion by Jere Day, second by Sarah Ploeger to cease nominations. Motion carried. Brandon Baker appointed as Treasurer by white ballot vote, $5: 1: 1$.
