A special reorganization meeting of the Board of Education of Independent School District No. 912, Milaca, MN was held at the Board Room on Monday, January 4, 2010.

The meeting was called to order at 6:30 pm by Chairperson, Pat Nelson. Upon Roll Call, the following members were present: Jeff Larson, Jackie Struffert, Aimee Struffert, Jody Chambers, Todd Quaintance, Linda Ramson, Pat Nelson. Jerry Hansen, Superintendent, was also present.

Approval of Agenda

Motion by J. Struffert, second by T. Quaintance, to approve the agenda. Motion carried.

Items on Which Board Discussion and Action is Requested

Election of School Board Officers by paper ballot:

- L. Ramson nominated Pat Nelson as Chairperson, second by J. Chambers. J. Struffert nominated Aimee Struffert, second by T. Quaintance. Pat Nelson received 5 votes, A. Struffert received 2 votes. Motion carried to appoint Pat Nelson as Chairperson.
- L. Ramson nominated Aimee Struffert as Vice-Chairperson, second by J. Chambers. No other nominations for Vice-Chairperson. A. Struffert received 7 votes. Motion carried to appoint Aimee Struffert as Vice-Chairperson.
- J. Struffert nominated Linda Ramson as Clerk, second by J. Larson. No other nominations for Clerk. L. Ramson received 7 votes. Motion carried to appoint Linda Ramson as Clerk.
- J. Chambers nominated Jackie Struffert as Treasurer, second by T. Quaintance. No other nominations for Treasurer. J. Struffert received 7 votes. Motion carried to appoint Jackie Struffert as Treasurer.

Motion by A. Struffert, second by J. Struffert, to designate the *Mille Lacs County Times* as the newspaper for all official school business. Motion carried.

Motion by J. Struffert, second by A. Struffert, to appoint the firm of Kennedy-Graven as legal counsel for the District. Motion carried.

Motion by J. Chambers, second by A. Struffert, to authorize the Superintendent and/or Business Manager to make short-term investments, deposits, transfers, withdrawals and electronic funds transfer from savings to other financial institutions. Authorize the Superintendent and/or Business Manager to make wire transfers of school district funds to approve financial institutions. Authorize the Business Manager to use facsimile signatures for all school district checks and orders. Authorize the Superintendent to lease, purchase, and contract for goods and services within the general budget categories pursuant to MS 123.37. Motion carried.

Motion by A. Struffert, second by J. Chambers, to direct the Superintendent to send out request for proposals to Greater MN Credit Union, Milaca; First National Bank, Milaca; and Bremer Bank, Milaca. Motion carried.

Motion by J. Chambers, second by J. Larson, to accept the agenda and consent agenda format. Motion carried.
