DEBATE

Debate is the art of argumentation. The Maine Forensic Association sponsors two forms of debate:

- **Lincoln-Douglas** is a debate in which individual debaters defend values rather than policies. Every two months, a new value-oriented topic is presented to the student (e.g.: "Lying with the

intent to protect is justified.” “Competition is superior to cooperation as a means of achieving excellence.” “The brotherhood of man is stronger than the sovereignty of nations.”).

- **Public Forum** is an event in which teams of two debate a new topic each month. It differs from policy debate in that sides (Affirmative and Negative) and order (speaking first or second) are chosen at the start of the debate by a coin toss, as in sporting events. A “Crossfire” period allows questions from all four debaters at once, and the “Last Shot” period is a chance for each debater to present the one argument he/she thinks will win the debate. The entire debate lasts 33 minutes.

SPEECH

Speech is the art of oral communication. Maine leagues compete in 11 categories of speech:

- **Humorous Interpretation:** Student interprets a humorous piece of literature (5-10 minutes).
- **Dramatic Interpretation:** Student interprets a dramatic piece of literature (5-10 minutes).
- **Original Oratory:** Student presents his or her own work on a theme with supportive evidence (5-10 minutes).
- **Prose Reading:** Student reads a piece of literature (5-10 minutes).
- **Poetry Reading:** Student reads a piece of poetry (5-10 minutes).
- **Story Telling:** Student presents a story from an oral tradition (5-10 minutes).
- **Ensemble:** Students combine to present a piece of a literary work or play (5-15 minutes).
- **Duo:** Two students combine to present a piece of a literary work or play (5-10 minutes).
- **Domestic/Foreign Extemporaneous Speaking:** Student speaks on a given current events/foreign affairs current events topic (5-7 minutes).
- **Original Works:** Students create and present their own play, story, etc. (5-10 minutes).
- **Oratorical Declamation:** Student presents a published speech that its author delivered as a public address (5-10).

CONGRESSIONAL DEBATE

Student Congress is an activity that has students writing legislation, running an active session of congress, learning parliamentary procedures, and developing arguments for and against proposed bills. Students take responsibility for all aspects of this event with some guidance from adult parliamentarians. The event is held in conjunction with speech and debate meets throughout the season.

GENERAL INFORMATION

The Maine Forensic Association's debate and speech tournaments are held on Saturdays. Students compete four to six times during a tournament.
