Cooperative Individuals Participating At Regional/State Championships

Schools with athletes participating as cooperative individuals (sending schools) at other schools (receiving schools) that compete in different classes are asked to verify where their athletes will be competing at the upcoming regional and state championships. Just prior to the championships, schools with individual athletes, will receive an e-mail from the MPA office listing those who have been registered.

If an athlete from the sending school is

competing at the same venue as that of the receiving school, then the coach from that school may serve as the athlete's coach at the championship. If the athlete is competing at a different venue, the sending school is reminded that the athlete must be accompanied by an eligible coach at the regional or state championship. If a school has a question about where an athlete is competing, contact the MPA office.

Electronic Ticketing

The MPA continues to offer electronic ticketing at most championship events being held this winter. Fans will have the option of being able to purchase electronic tickets prior to the event. For all contests involving ticketing, except for the cheerleading championships and basketball games being held at the Cross Center in Bangor and the basketball games being held at the Cross Arena in Portland, tickets may be purchased online at https://gofan.co/app/school/MPA.

For teams competing at the Cross Insurance Center in Bangor or at the Cross

Insurance Arena in Portland presale tickets may be purchased online at http://www.ticketmaster.com.

Tickets for all events may still be purchased at the ticket office on the day of the event. There will be no electronic tickets for swim. Due to limited seating at the swim venues, all tickets will be on a first-come, first-served basis.

Please note that there is an online convenience fee charged by Ticketmaster and Huddle Ticket for all online ticket purchases.

Notes and Updates

Boys and Girls Lacrosse Field Markings—Schools now have the option of having one set of unified girls' and boys' lacrosse field markings. These markings must follow the field diagrams outlined in the rulebook.

Cooperative Team Policy — Schools with **individual students** wishing to participate as individuals with another school in the spring sports of tennis and outdoor track must apply on a form that can be found by clicking **HERE** and must be filed prior to the first countable contest (April 16, 2020). Participation is defined as attending practices and contests with the school team. Schools with cooperative teams in sports such as football and ice hockey are reminded that these teams are approved for no more than a two-year period and are aligned to the classification cycle. Schools wishing to start cooperative teams must apply three months in advance of the starting date of the applicable sport season. The deadline for applying for a cooperative team in the fall is June 4, 2020. Regulations for cooperative individuals or cooperative teams may be found on pages 25-26 of the MPA Handbook.

Team Benches—As tournament time arrives for winter sports, schools are reminded that there are restrictions as to who can sit on team benches or, in the case of wrestling, swimming, skiing, and indoor track, who can be in the areas restricted to teams. Only certified coaches who are on a school's certified coaching list may be on the bench or in the team area. In addition, managers or other non-playing student personnel must be high school students.

Middle School/High School Competition—A reminder to schools (with the exception of those with 60 or fewer students per gender) that middle school students are not allowed to practice with or compete against high school teams. This would include freshman and JV teams. A school may request a waiver, in order to fill a subvarsity schedule, to schedule a game with the middle school within their district.

Undergrad Tournaments

This is a reminder that following the winter season (February 22), the Sport Season Policy does not allow an MPA member school's team to play or practice outside the sports season, use school equipment or facilities, be transported by the school or a school-affiliated organization, or use the school name.

Under the Sport Season Policy, coaches or advisors employed by the school system are prohibited from coaching or giving instruction about a sport to members of a school team individually or collectively outside of their normal sport season.

Coaches may be present at games in which athletes from their school are participating as long as it is taking place in a public facility and no coaching and/or instruction is taking place.

Private School Law

Those students that attend a recognized private school, or an approved private school with an enrollment of 60 or fewer students, and reside in your community may request approval to participate in cocurricular activities at your school. Denial to participate may occur if the school does not feel they have the "capacity" to provide the student with the opportunity to participate in the activity. If approval is withheld a written explanation must be provided to the student's parent or guardian stating the reason or reasons for the decision to withhold approval.

What Image Does Your P.A. Announcer Project?

"A P.A. announcer is not a cheerleader, or a circus barker, or a hometown screecher. He's a reporter."

—Bob Sheppard, Stadium Announcer, New York Yankees, 1951-2007

Have you ever attended a game where the public address announcer sounded like what Bob Sheppard described as "a cheerleader, or a circus barker, or a hometown screecher"? What was your impression of the announcer and/or the home team and its administration?

Like many things athletic, the "call of the game" by some high school public address announcers in recent years has taken on more of the persona of an NBA or NFL sports arena or radio or television play-by-play announcer; glorifying the home team while ignoring or minimizing the effort of the visiting team; calling the attention to themselves rather than the game on the field or court, whether it be during the introduction of starters or the description of the action on the field or court.

Rather than "public address" announcers let's think of it as "professional approach" announcers. Announcers need to recognize they are part of the game's crew of officials, just like the game and play-clock operators or the official scorer. As such, their focus should be on presenting the game in a positive, sportsmanlike manner, treating both teams with equal respect, reporting the facts of the game in an even-handed manner.

The announcer needs to be conscious of the fact that athletics at this level is about sportsmanship, values, and respect. Set the tone with a scripted introduction to the contest. The announcer's job is to enhance the game experience, not entice or incite the crowd. Their job is to "highlight the play," but leave the

play-by-play for the radio or television coverage. Give only the necessary information! For example, in football, announce the ball carrier or passer and receiver, tackle by, yardage gained or lost, down, distance, and yard line. This should be completed before the offensive team leaves the huddle, so in most instances, less (words) is more.

Announcers need to know the rules of the game, especially any recent rule changes. A chart of officials' signals should be close at hand. Announcers shouldn't anticipate or guess what an official is calling. If a flag is thrown in football it is appropriate to announce "a flag on the play," but whether a thrown flag or a blown whistle, WAIT on the official's signal before announcing the call.

While you hope you never have to use them, always be prepared for emergency situations and know inclement weather procedures. Know the appropriate evacuation routes, have them in writing, and be able to communicate them in a calm reassuring tone.

One means of helping your public announcer become the best possible representative of your school would be to enroll them in the *National Association of Sports Public Address Announcers*. Each member receives the quarterly copy of the NASPAA publication, *The Voice*. It is a great resource with useful, informative articles and tips. Public-Address Announcers Guidelines

- Be early and be prepared. If possible arrive at the facility one hour before game time. Visit with both coaches to ensure proper pronunciation of players and coaches names. Also, review any scripted pre-competition announcements required by the school (i.e., National Anthem, emergency procedures, concession and facility announcements, etc.).
- Work with the officials. Communicate with the officials before the game regarding plans for the pre-competition, during competition and post-competition announcements and ask for their feedback. Make sure the final plan works for all involved.
- 3. **Promote sportsmanship.** Create a positive competitive environment through non-biased promotion of fair play. This may be in the form of a scripted pledge of sportsmanship and/or in the vocal display of respect for all participants (players, coaches and officials).
- 4. Stick to the basics. Deliver pertinent information while

- avoiding the use of play-by-play and cheerleading.
- 5. *Be accurate.* Understand the proper terminology used for the sport and avoid the use of slang terms. Wait until officials complete their call(s) before reporting to the spectators.
- 6. *Never talk over the action*. Understand the appropriate information to be announced and the proper time in which to announce for each sport.
- 7. **Be on your toes and keep your cool.** Weather alert, emergency evacuation, severe injury are possible reasons that play could be delayed, and communication becomes essential to facilitate coordinated school/facility emergency procedures. Be familiar with the emergency management plan. The calm tone and direct delivery of instructions to participants and spectators is essential.
- 8. Be professional. Take your job seriously by addressing coaches, officials, administrators and athletes with respect regardless of team affiliation. Be properly dressed and exhibit professional behavior always by respecting all school/facility policies.

Participation in education-based high school activities helps students develop important life skills such as dedication, perseverance, commitment, teamwork, and a sense of fair play. Performing arts activities provide students opportunities to develop skills needed to be successful both in life and at work. Music, theatre, and speech and debate activities are ideal for developing what has been called the Four Cs of 21st century skills—critical thinking, communication, collaboration, and creativity.

The National Association of Colleges and Employers (NACE), a non-profit group that links college career placement offices with employers, conducted a survey in 2014 asking hiring managers to prioritize skills they consider important when recruiting new employees. Those at the top of their list included leadership, along with the ability to work in a team structure, to make decisions and solve problems, to communicate effectively with people inside and outside the organization, and to plan, organize, and prioritize work.

Being a team player in a performing arts group means students must accept different roles for different situations. At times, a student may be a cheerleader to help and encourage

those who are frustrated and struggling to master their part. It could require mentoring of new members who are learning the culture of the group. Sometimes it means becoming a peacemaker when tensions flare between members. And other times it means stepping up and becoming a leader, even if they have not been given that title. Group projects do not end with high school, and the ability to work with diverse people in a variety of circumstances is a skill that will serve these students well.

It is not surprising, of course, that students in performing arts become better communicators, but not just from the self-confidence and fluency they gain through performance or public speaking. Successful performers are good listeners as well. They don't just hear, but learn to listen to nuances, to silences, to choice of words as part of the message. Effective communication is a two-way process, and learning to truly listen is essential.

Franklin D. Roosevent once said, "We cannot always build the future for our youth, but we can build our youth for the future." Offering opportunities for students to participate in performing arts activities is an excellent way to do so.

Girls Lacrosse Rules Changes—2020

- **2-2-5d, 2-4-3b, c (NEW):** Separates and distinguishes the crosse inspection requirements for the front and back face of the stick. Limits the inspection requirements of the back of the pocket to ensuring the ball rolls out of the back of the pocket when placed in the upper third of the head at its widest point when tilted at 90 degrees. **Rationale:** Clarifies the requirements for crosse inspection on the back face of the pocket.
- **2-7-2**: All eyewear on the playing field must be SEI certified and listed on the SEI website starting January 1, 2020 and clarifies that all eyewear must bear the SEI mark for certification by January 1, 2025. **Rationale:** Reduces burden on consumer to purchase new eyewear before 2025 while maintaining the requirement to have SEI certified eyewear by January 1, 2020.
- **2-7-4:** Equipment shall not be modified from its original manufactured state and shall be worn in the manner the manufacturer intended it to be worn. **Rationale:** Clarifies the responsibility to maintain the integrity of protective equipment for risk minimization purposes.
- **2-8-4 (NEW):** Electronic devices, video replay, or television monitoring equipment shall not be used for any review of an official's decision. **Rationale:** Establishes that video replay is not allowed for reviewing official's decisions.
- 4-2-3a thru g; 4-3-3 a thru d NEW; 4-7-7c; 5-1-2; 5-1-3b; 5-1-3 PENALTIES 1 & 2; 5-2-5a; 5-3-1c; 5-3-1e(1), (2) & (3) iv; 5-4-4c; 5-5-3a & b; 6-3-1b thru d; 7-3 PENALTIES 1; 9-1 PENALTIES for Violation of 9-1-1a, b and e-q: 1, 3a, 3d & 4; 9-1 PENALTIES for Violation of 9-1-1d; 10-1z PENALTIES 1, 3, 4d, 4e, NOTE, 5, 5b, 6, 8d, 9; 11-2-1 PENALTIES 2, 4, 5, 5a, 5b: Provides for free movement. Rationale: Improves pace of play while keeping up with the current trends of the game and athleticism of the student-athlete.
- **5-2-2:** Allows for any number up to twelve players of each team to be on the field before the start of each draw. **Rationale:** Creates consistency in the rules related to number of players allowed on the field during play.
- **6-3-1a**, **6-3-2a**: When the ball has gone out of bounds, it is established that the opponent nearest the ball may commence

- play with a self-start without coming to a full stop inbounds. **Rationale:** Creates consistency of penalty administration and maintains pace of play.
- **6-3-2:** When a shot or deflected shot on goal goes out of bounds, the player whose body or crosse is inbounds and nearest to the ball when it crosses the boundary will gain possession of the ball. **Rationale:** Clarifies that the position of a player's body or stick shall be considered when determining who is closer to the ball when a shot crosses the boundary line.
- **9-1b**: Adds language in covering a ground ball to include foot, body or crosse. **Rationale**: Clarifies the minor foul for covering.
- **10-1c**: Adds language to expand a check to the head to include the neck as a major foul. **Rationale**: Emphasizes the inclusion of the neck as a check to the head.
- 10-1j(1) (NEW): Self-starting before the whistle or any movement simulating the beginning of play designed to gain an advantage over one's opponent is a false start. Rationale: Establishes that self-starting when self-start is not an option is a major foul.
- **10-1 PENALTIES 4:** For a major foul by a defense player between the arc and the fan, the free position will be taken on the 12-meter fan closest to the spot of the foul. **Rationale:** Allows for consistent administration of the free position and limits potentially dangerous play in the critical scoring area.

Baseball Rules Changes—2020

3-1-4: Designated Hitter (DH) can be used in two ways. The DH can be listed as the tenth starter replacing one of the other nine players when it is their turn to bat. The other method is that that any one of the starting defensive players can be their own DH (in effect having two positions) within the confines of the rule requirements. **Rationale:** This rule change assists coaches with an alternative to keep their better players in the game to contribute to the offensive output of the team and give another player a chance to participate on defense. In addition, considering the pitch count rules, this change would help pitchers to keep their bat in the game, but can come out of the game defensively to protect their arms from overuse.

Track and Field & Cross Country Rules Changes—2020

4-6-5g, 8-6-1e: Clarifies that a competitor should not be penalized for helping another competitor who is distressed or injured when no advantage is gained by the competitor who is assisting.

Rationale: The committee believes when no advantage is gained by a competitor helping a distressed or injured competitor, the competitor assisting should not be penalized for exhibiting good sportsmanship.

5-3-3 & 4, 5-10-6 thru 11: Clarifies that in the 4x100-meter relay and 4x200-meter relay, and other relays with legs of 200 meters or less, each exchange zone will be 30 meters long. All exchange zones for races in excess of 200 meters will remain at 20 meters.

Rationale: In the 4x100-meter relay and 4x200-meter relay, and other relays with legs of 200 meters or less, each exchange zone will be 30 meters long. All exchange zones for races in excess of 200 meters will remain at 20 meters.

6-2-6: Clarifies that it is illegal to run backward or in the opposite direction (non-legal direction) on a horizontal jump, pole vault or javelin runway.

Rationale: This change promotes a more organized and efficient warm-up period.

6-3-2-b-4-a: This change provides metric measurements for tie-breaking jump-offs for vertical jumps.

Rationale: The committee established appropriate metric increments for tie-breaking jump-offs in the vertical jumps.

6-9-5: The length of long jump and triple jump pits constructed after 2019 shall be at least 23 feet (7 meters).

Rationale: Clarifies the language of the 2019 rule change for long jump and triple jump pits and ensures pit measurements are within industry standards for safety.

8-1-1: Clarifies cross country course markings.

Rationale: The reorganization of the rule states that a course should be clearly marked with any or all of the methods listed in the rule.

8-1-3: Clarifies cross country course layouts.

Rationale: This rule change will not eliminate courses that may be used for smaller meets with limited numbers of participants. The additional language provides a recommended minimum distance for straightaways at the start of all meets.

6-1-1: Prior to starting the delivery (pitch), the pitcher shall take a position with the pivot foot in contact with the pitcher's plate. **Rationale:** Clarifies that the pivot foot must be in contact with the pitcher's plate, rather than on the top surface of the pitcher's plate.

9-1-1 EXCEPTION c: A run is not scored if the runner advances to home plate during action in which the third out is made by the preceding runner who is declared out on an appeal play. **Rationale:** Clarifies that on any appeal play, a run is not scored if the third out is made by a preceding runner.
