Write a Persuasive Composition:

- a. Include a well-defined thesis (i.e. one that makes a clear and knowledgeable judgment).
- b. Present detailed evidence, examples, and reasoning to support arguments, differentiating between facts and opinion.
- c. Provide details, reasons, and examples, arranging them effectively by anticipating and answering reader concerns and counterarguments.

The introductory paragraph is the first-paragraph in the persuasive essay.It

should have three parts: an attention-catcher, a thesis, and a preview.

- Asking a Question
- Ouotation
- Anecdote
- Startling Fact or Statistic
- Imaginative Scenario

A thesis is a clearly worded statement telling readers exactly what the writer intends to do in the essay.
