On a motion made and seconded, the PCOA minutes from the June 16, 2014 meeting were unanimously approved (13-0).

On a motion made and seconded, the Committee voted to move to Executive Session.

PCOA EXECUTIVE SESSION

The following items were discussed in Executive Session: Finance Committee report; 2013-2014 Revenue Share to RIIL schools and 2014-2015 Budget.

RIIL FINANCE COMMITTEE REPORT, BUDGET 2014-2015 AND RIIL REVENUE SHARE

- NFHS Heart of The Arts Award
 - Mr. Mezzanotte encouraged all schools to nominate someone for the NFHS Heart of The Arts Award. The recipient must be an individual from a high school that is a member of an NFHSmember athletic or activity association—the Rhode Island Interscholastic League.
- NFHS Concussion Summit Guidelines
 - On a motion made and seconded, the Committee approved in principle the NFHS Concussion Summit Guidelines. Guidelines will be forwarded to the Football Sport Committee for discussion and recommendation.
- 2013-2014 High School Sports Related Injury Surveillance Study

PCOA NEW APPOINTMENT

The Committee on Athletics reviewed and discussed a number of applications of those administrators interested in serving on the PCOA. On a motion made and seconded, the Committee voted (15-1) to approve the appointment of Jay Brennan, Principal of Bishop Hendricken High School.

SPRING SPORTS ALIGNMENT - 2014-2016

On a motion made and seconded, the following spring sports alignments were approved for two years (2014-2016): Fast Pitch Softball, Baseball, Boys' Lacrosse, Girls' Lacrosse, Boys' Volleyball, Boys' Tennis, Boys' and Girls' Track and Golf. Approved Alignments will be sent to all schools.

COOPERATIVE TEAM APPROVALS - WINTER

The following winter cooperative teams were approved for two (2014-15 & 2015-16) years in <u>Boys Hockey</u>: Johnston/North Providence, PCD/St. Rays/Wheeler and Rogers/Middletown/Rocky Hill. The following winter cooperative teams were approved for two (2014-15 & 2015-16) years in <u>Girls Hockey</u>: Barrington/Mt. Hope/Portsmouth, Cranston/East Greenwich, Warwick Schools, Lincoln/Cumberland, Narragansett/NK/SK and Smithfield/North Smithfield/Coventry. Tolman/Shea was approved for two (2014-15 & 2015-16) years in Boys Swimming. Also, the following were approved for one year only with a phase out period: Burrillville/Ponaganset - Girls Hockey, Cranston West/East - Boys Hockey and West Warwick/EWG Boys Hockey.

CHEER PROPOSAL

Mr. Mezzanotte reported the RIIL will recognize Cheer (as it presently exists) as an activity – not a sport. Courts have ruled that Cheer is an "activity" not a sport. Result: Cheer is not bound by RIIL Rules and Regulation. On a motion made and seconded, the Committee unanimously (16-0) approved the new cheerleading structure and protocol to begin in the spring of 2015 which will include the addition of a "Game Day Competition" in addition to the annual competition championships held in the winter. More information to schools will follow.

RIIL RULES VIOLATION

The Lincoln School: Article 6, Section 6 - Use of an Ineligible Athlete - Field Hockey

On a motion made and seconded, the Committee unanimously voted (16-0) to impose a fine of \$100 for violating Article 6, Section 6. The Committee also reminded The Lincoln School to be sure that all the athletes are added to the eligibility lists prior to them participating in any future competition.

Middletown High School: Article 6, Section 6 – Use of an Ineligible Athlete – Girls' Volleyball

On a motion made and seconded, the Committee unanimously voted (16-0) to impose a fine of \$100 for violating Article 6, Section 6. The Committee also reminded Middletown High School to be sure that all the athletes are added to the eligibility lists prior to them participating in any future competition.

St. Patrick Academy: Article 3, Section 1 – Eligibility List – Boys' & Girls' Cross Country

On a motion made and seconded, the Committee voted (14-2) to impose a fine of \$200 for violating Article 3, Section 1. The Committee also reminded St. Patrick Academy to be sure that all the athletes are added to the eligibility lists prior to them participating in any future competition.

RIIAAA REPORT

Mr. Vetelino recommended combining a number of sport committees and explained the benefits of doing so. The RIIAAA will present recommendations about combining sport committees.

RIIL STUDENT ADVISORY BOARD

Mr. Lunney reported the Student Sport Leaders Conference presented by the Rhode Island Army National Guard will be held on December 12, 2014 at the Crowne Plaza Hotel.

RIIL SPORTS MEDICINE ADVISORY COMMITTEE

Mr. George Finn, Chair of the SMAC, presented several issues that were brought up at the last SMAC Meeting regarding the importance of Pre-Participation Physical Examinations and that a number of Rhode Island athletic trainers will be participating in the RIO (Reporting Information Online) survey.

RIIL RULE REVISIONS: DISCUSSION ITEMS

Mr. Mezzanotte reported on revision of rules which would allow athletes to play more than one sport during a season. In addition, he provided survey results regarding a rule revision which would allow member schools to participate in non-league games against non-member schools. Committees will be established to review these results and discuss possible RIIL rules revisions.

RIIL RULE CHANGE PROPOSAL

On a motion made and seconded, the Committee on Athletics unanimously (13-0) voted to approve the following change to Article 1, Section 4, Governing and Operations:

Each PCOA member casts a vote for a candidate. If there are more than two (2) candidates, the candidates who received more than 50% will be selected. If no candidate receives the necessary 50% the two (2) with the most votes will be selected, and run-off election will be held to select the candidate.

RIIL RULES VIOLATIONS

Cranston High School West: Article 6, Section 6 – Use of an Ineligible Athlete – Boys Basketball

On a motion made and seconded, the Committee unanimously voted (13-0) to impose a fine of \$100 for violating Article 6, Section 6. The Committee also reminded Cranston High School West to be sure that all the athletes are added to the eligibility lists prior to them participating in any future competition.

Lincoln High School: Article 6, Section 6 – Use of an Ineligible Athlete – Boys Basketball

On a motion made and seconded, the Committee voted (12-0-1) to impose a fine of \$100 for violating Article 6, Section 6. The Committee also reminded Lincoln High School to be sure that all the athletes are added to the eligibility lists prior to them participating in any future competition.

Hope High School: Article 3., Section 6., Use of an Ineligible Athlete - Freshman Boys' Basketball

On a motion made and seconded, the Committee unanimously voted (13-0) to impose a fine of \$100 to Hope High School and wins on January 13th & January 20th must be forfeited. The <u>Freshman Boys' Basketball</u> standings were changed accordingly.

Mount Pleasant and Shea High School Football Incident

The Committee on Athletics reviewed and discussed several incidents that occurred on November 14, 2014, between the Shea High School and Mount Pleasant High School football teams.

The following incidents were reviewed:

- A pre-game argument between the head coaches of both teams
- Ejection of players from the Mount Pleasant High School football team
- Post-game supervision of the Mount Pleasant High School football players

On a motion made and seconded, the Committee unanimously (13-0) approved the following sanctions:

- 1. Both the Shea head coach and Mount Pleasant head coach be suspended from coaching the first non-league football game in the 2015 season for inappropriate, unprofessional conduct in the presence of their respective teams during the pre-game warm-ups.
- 2. Due to what was perceived as a lack of supervision by the Mount Pleasant coaching staff at the conclusion of the Shea football game and in instances that took place during the 2014 season:
 - a. The Mt. Pleasant High football program be placed on probation for a period of 3 years (2015-2017)
 - b. Mt. Pleasant High principal submit a plan designed to improve supervision/and sportsmanship at all football games.
 - c. Mt. Pleasant administrator be present on the sidelines at all home/away football games (2015 season).

Boys Ice Hockey: Burrillville and North Kingstown High School Incident

The Committee on Athletics reviewed and discussed a hockey incident that took place on December 6, 2014 between a player from Burrillville High and player from North Kingstown High.

RI INTERSCHOLASTIC ATHLETIC ADMINISTRATORS ASSOCIATION (RIIAAA) REPORT

Specifically, schools may now schedule <u>any non-league game against teams that are not members of any NFHS State Association</u>. As a result, schools may now choose to participate against a <u>high school</u> team that does not conform to the rules and regulations of the RIIL.

In another matter, Mr. Lunney reported the sub-committee has met twice regarding revisions of Article 3., Section 1., C.1 and Article 7., Section 1.A. (Allow athletes to play more than one sport during a season). The sub-committee's findings will be discussed with athletic directors and will be brought forward at the March meeting.

FALL SPORTS CHAMPIONSHIPS - FOOTBALL

On a motion made and seconded, the Committee unanimously approved (13-0) the 2014 football championship report.

RIIL RULE REVISIONS: COMMITTEE REPORTS

Mr. Chris Cobain and Mr. Tom Marcello, members of the Simultaneous Play Committee presented their findings on the matter to allow athletes to play more than one sport during a season. The PCOA continues to discuss issues relating to a rule change that would allow students to play more than one sport during the season. (Revision of Article 3., Section 1.C-1 and Article 7, Section 1A – allow athletes to play more than one sport during a season.) RIIL will exam rule.

FALL SPORTS

FOOTBALL OFFICIALS ASSIGNER: On a motion made and seconded, the Committee unanimously (14-0) approved the recommendation from the Football Committee to extend the contract of Jim Ashley as the RIIL Football Official Commissioner.

FOOTBALL COMMITTEE RECOMMENDATIONS: On a motion made and seconded, the Committee unanimously (14-0) approved the recommendation from the Football Committee to approve the following "Mercy Rule" in all regular season and playoff games:

- If there is a 35 point differential during the 4th quarter, the game clock will not be stopped unless there is an injury time out or a regular team time out.

In addition, the PCOA supports all recommendations made by the Football Committee regarding the Fundamentals for Minimizing Head Impact Exposure and Concussion Risk in Football. As a result, athletes may <u>not</u> participate in games played on consecutive or on the same day:

- Football coaches must consider the amount of time a player is allowed to complete I games (varsity, junior varsity and freshman) during a week.
- Football week is recognized as Tuesday Tuesday.

BOYS' SOCCER COMMITTEE RECOMMENDATIONS: On a motion made and seconded, the Committee unanimously (14-0) approved the following rule changes from the Boys' Soccer Committee to Article 24 (Boys' Soccer):

- During the regular season, the field clock will be used but turned off at the 2:00 minute mark. The game official will then be responsible for maintaining the clock until the end of the game. If the school requests an official timer (supplied by the RI Boys Soccer Officials Association, and paid for by the school) he/she will maintain the field clock and it will be the official clock.
- During all playoff games (qtr, semi, final) the RIIL will supply a game official to run the Official Field Clock.
 - Note: In the event that a team is substituting players in blatant attempt to reduce the actual playing time the official may stop time during these substitutions.
- If a team/coach is issued five (5) yellow cards during the playoffs, the team will lose one player and play the remainder of the game short -handed. Additionally, if the same team is issued two (2) more yellow cards they will lose another player and play two short.
 - Note: the coach will no longer be ejected if his/her team accumulates five (5) cards.

- During all regular season games, the home team must provide a scorer table, a scorebook and a scorer. In addition in accordance with Art 24 Section 2 e: The home team MUST have a scorer located at mid-field (table is not a requirement). If a scorer is not provided at mid-field, the home team coach will be issued a yellow card prior to the start of the game.
- During all games if a coach is assessed a yellow card, he/she must remain seated on the bench.

WINTER SPORTS & CHAMPIONSHIPS

GYMNASTICS – Melissa Gendreau, Director of Gymnastics – the RIIL received a request from the Gymnastics Committee to request changes to Article 3., Section 3., Individual Sport Participation Limits – Co-op Teams. On a motion made and seconded, the Committee unanimously (14-0) approved the following change: Gymnastics may now have an individual limit of 6 with a combination of 10.

On a motion made and seconded, the Committee unanimously approved (14-0) the following 2015 winter championship reports: Boys & Girls Indoor Track, Wrestling, Boys & Girls Swim, Gymnastics and Boys and Girls Basketball.

RULES VIOLATIONS

<u>Burrillville High School</u> self-reported a violation of Article 7, Section 6.D.1. (Coaching out of Season) (Girls Soccer). As a result, the Committee unanimously voted (14-0) to impose the following sanctions:

- 1. Suspend the Girls' Soccer asst. coach for the first two (2) League games of the 2015 Girls Soccer season.
- 2. Fine in the amount of \$200.00.
- 3. Place the Burrillville HS Girls' Soccer program on probation for a period of two (2) years (2015-16 & 2016-17).

Failure to pay within 30 days will result in a late fee of \$100 and/or a "show cause" hearing before the Principals' Committee on Athletics as to why the school failing to pay should not be suspended from further completion in the RIIL in accordance with Article 6., Section 3.
