RIIL RULE VIOLATIONS:

As a result of Smithfield high school's investigation and self-reporting of eleven (11) violations of Article 3., Section 4., the Committee voted unanimously (11-0) to approve the following sanctions:

- 1. The Smithfield HS Athletic Program is placed on probation for a period of three (3) years (2016-17, 2017-18 & 2018-19)
- 2. Smithfield HS will be fined a sum of \$1,100.
- 3. Smithfield HS fully implements all aspects of the Athletic Program Improvement Plan.

In addition, Mr. Kelley submitted and Athletic Program Improvement Plan. It was noted that **all** athletes in violation of Article 3., Section 4., had no impact on state championships. WINTER SPORTS

Ice Hockey – George Egan and Terry Lynch, Co-Sport Directors – On a motion made and seconded, the Committee unanimously (7-0) approved a revision to Article 22, Hockey, Section 1.F:

- F. Beginning in December 2016 RIIL Rule Change
 - 1. Establishment of a system that would penalize and suspend players who have exceeded the maximum number of penalty minutes during the regular league season and playoffs.
 - Any player who has accumulated 50 or more penalty minutes during the regular season will be suspended for two (2) league games and any games in between (including playoffs). At the conclusion of the regular season, the first level of penalty minutes will be raised from 50 or more penalty minutes to 60 or more penalty minutes for the playoffs. Any player who accumulates 60 or more penalty minutes (regular season and playoffs combined) will be suspended for the next (2) playoff games.
 - In addition, any player who accumulates a total of 70 or more penalty minutes will be suspended for the remainder of the hockey season (including playoffs).
 - If the player accumulates the 50/60/70 penalty minutes level during the last game of the season, he/she will sit out the first two (2) league ice hockey games in the next year or if a senior, two (2) league games in the next sport season.

SPRING SPORTS

Baseball – Terry Lynch and Mike Whaley, Co-Sport Directors – On a motion made and seconded, the Committee unanimously (7-0) approved a revision to Article 14, Baseball, Section 1.B:

B. The RIIL Pitching Limitations Rule is as follows:

Max Pitches 1 Day - 110

Days' Rest	76+	3 Days
	51-75	2 Days
	26-50	1 Day
	25 or Less	0 Days

Baseball revision continued...

Player reaching a max count can finish the batter.

If a pitcher reaches a day rest limit in the middle of an at bat and is removed from game after that batter, his official pitch count number will revert back to what it was at the start of the at bat.

Example: If 25 or less pitches in a game doesn't require any rest for next day. Pitcher starts a batter with 23 pitches already thrown. Pitcher throws 5 pitches and ends up with 28. Pitcher is then removed from game. His official pitch count reverts back to 23 and is eligible to pitch the next day.

Home Book (Official Book)

-In between innings both coaches should meet to confer what they had for a pitch count.

*Coaches need to post the pitch count after every game on the RIIL website within 4 hours. If the coach does not post the pitch count within 24 hours they will be suspended for one game for the next game on their schedule, no fine.

RULES VIOLATIONS

Pilgrim High School: Article 3, Section 4: (Use of Ineligible Athlete)

On a motion made and seconded, the PCOA unanimously (11-0) voted to sanction Pilgrim High School for a violation of Article 3, Section 4 (Use of Ineligible Athlete) of the RIIL Rules and Regulations. As a result, the Boys' Hockey team had to forfeit one game versus Johnston/N. Providence team on December 30, 2016. In addition, Pilgrim High School is assessed a \$100 fine.

The Prout School: Article 3, Section 6: (Transfer Rule)

SCHOOL REQUESTS

The Committee received a letter from The Lincoln School to join Girls Varsity and JV Soccer (Division 2) and Girls Cross Country beginning fall of 2017. On a motion made and seconded, the Committee unanimously approved (15-0) Lincoln Schools request.

The Committee received a letter from Exeter/West Greenwich High School and the Prout School requesting a waiver of Article 3, Section 1 J of the rules and regulations to allow EWG/Prout to form a Co-op in Football. The application does not meet the established Article 3, Section 1 J guidelines because EWG High School exceeds the limit of 20 participants. On a motion made and seconded, the Committee denied (4-10) the request.

On a motion made and seconded, the Committee denied (15-0) a request submitted by Mr. Rosendo Fontecha to appeal a previous ruling denying his son Nicolas request to participate in Boys' Tennis under the RIIL Alternate Sports Program.

RIIL RULE REVISIONS:

On a motion made and seconded the following RIIL Rules Revisions were unanimously (15-0) approved:

- 1. <u>Article 11, Section 5 (Media Credential Policy)</u> "Media journalists and photographers must stand clear of the awards presentation area and are asked to refrain from conducting post-game interviews until after the awards ceremony has been completed,"
- 2. Article 3., Section 4A (Academic Eligibility) "At all times the athlete should have secured for the period from the beginning of the quarter or trimester up to the end of the regular marking period which shall not exceed a maximum of 12 weeks and a passing grade in 60% of the student's program (credits). A student who is not passing 60% of his/her program (credits) is ineligible to participate in games (league and non-league) until the end of the quarter or trimesters of the next marking period. This is a minimum standard for academic eligibility. Schools may choose to initiate a higher standard for academic eligibility. In this instance, the higher standard (school policy) will be supported by the RIIL."

RULES VIOLATIONS

Burrillville High School: Article 3, Section 4: (Academic Eligibility)

On a motion made and seconded, the PCOA unanimously (14-0) voted to sanction Burrillville High School for violating Article 3, Section 4 of the RIIL Rules and Regulations. As a result, Burrillville High School is assessed a \$200 fine and placed on probation for a period of one year.

Lincoln High School: Article 3, Section 4: (Academic Eligibility)

If the score remains tied after the 8th inning is completed, a 9th inning will be played. If the score remains tied after the 9th inning is completed, the International Tie Breaker rule will take effect beginning with the top of the 10th inning. Each team will start with a

runner on 2nd base and zero (0) outs. The runner is the last batter to make an out in the previous inning. At least one full inning is played, allowing each team the same chance to score. If the score remains tied, the same process will be used in each subsequent inning until a victor emerges."

The Committee then adopted the following closing motion: That any and all motions, amendments and actions by the Principals' Committee on Athletics and the Executive Officers of the Principals' Committee on Athletics to this date be reaffirmed and ratified.
