# Mt. Pleasant High School - Article 6, Section 13, Use of School Equipment During the Summer (Football)

The Committee reviewed the circumstances regarding Mt. Pleasant High School's violation of Article 6, Section 13, Use of School Equipment During the Summer. On a motion made and seconded, the Committee unanimously (15-0) voted to NOT penalize Mt. Pleasant High School. However, Mt. Pleasant HS should review the information in Article 6, section 13 and take the necessary steps to protect the school and district from any liability that may result from this practice in the future.

#### RIIAAA REPORT - KEITH CORY

Mr. Cory, President of the RIIAAA, provided an update regarding the RIIAAA's support and endorsement of the RI Principals' Committee on Athletics (RIPCOA) request for the RIIL to begin offering middle school sports starting in the fall of 2024. Mr. Cory also updated the Committee on the RIIAAA progress in establishing a state-wide coaches association to standardize fees, all-division/all-state and awards criteria. RIIAAA is working with individual sport coaches' associations on this project.

## RIPCOA REQUEST - MIDDLE SCHOOLS (GRADES 6-8)

On a motion made and seconded, the Committee unanimously (15-0) accepted the RI Principals' Committee on Athletics (RIPCOA) request for the RIIL to begin offering middle school sports beginning in the fall of 2024. The RIIL will be working with RIPCOA leadership during the 2023-2024 school year to develop a plan for the transition.

#### **OFFICIALS**

Mr. Lunney updated the Committee on a new agreement with RefReps in an effort to address the shortage of officials through Recruitment and Training. Also, he reported that the RIIL will be working with the officials' organizations during the 2023-2024 school year regarding the new agreements which will take effect beginning with the 2024-2025 school year.

## FALL SPORTS - MONDAY, AUGUST 21, 2023

First day of practice for football begins Monday, August 14. All other fall sports begin on Monday, August 21. The fall tournament dates and facilities have been confirmed.

## WINTER SPORTS – MONDAY, NOVEMBER 27, 2023

The winter sports schedules have been sent to all member schools. The commit date for all winter sports schedules is September 5. Also, the 2<sup>nd</sup> Annual Jiggs Cecchini CT/RI Basketball Challenge is being held on December 14, 2023. The tournament will be played at Mohegan Sun Arena and feature four games, two boys games and two girls games. Boys: La Salle vs Northwest Catholic and Barrington vs Bloomfield. Girls: Moses Brown vs Sacred Heart and North Kingstown vs East Hampton.
