## Information Regarding Section 504 of the Rehabilitation Act of 1973

Section 504 of the Rehabilitation Act of 1973 protects disabled students from discrimination on the basis of a disability. It is the responsibility of the school district to identify and evaluate learners who, within the intent of Section 504, need special services, accommodations, or programs in order that such learners may receive a free appropriate public education.

A learner who is protected under Section 504 is one who:

- Has a physical or mental impairment that substantially limits one or more major life activities, including learning; or
- Has a record of such impairment; or
- Is regarded as having such impairment.

Learners may be protected from disability discrimination and be eligible for services, accommodations, or programs under the provisions of Section 504 even though they are not eligible for special education pursuant to the Individuals with Disabilities Education Act.

## **Form Required for Prescription and Non-prescription Medication**

The administration of **prescription and non-prescription medication** at school requires a completed, signed medication administration form from the student's parent as well as the physician's signature. A written authorization is required and the written label must be provided as required by law before the administration of medication. **A completed consent form for administration of prescription and non-prescription medication is required.**
