 - i. Everytime you purse efforts to (1) educate yourself (2) educate students (3) work intentionally on HHB matters...DOCUMENT it.
- 10. Questions/Hypotheticals (Time Permitting)
 - a. Will be sharing materials with all ADs for their information

Impact on Athletic Director Role: With respect to student-to-student behaviors that might constitute HHB:

- Schools will be held responsible for STUDENT HHB conduct where the school can be shown to have received actual notice of information regarding the alleged conduct.
- Schools must therefore assign DESIGNEES to be available to receive and take in compliance of HHB behavior.
- TRAIN ALL EMPLOYEES to IDENTIFY such behavior when they see or hear.
- Educate students about HHB behavior
- Work to respond to sustaniated instances of HHB
- Work with students to increase awareness and to prevent HHB where possible.

VPA Report Sean Farrell

Baseball rule changed from 15 runs to 10 run mercy rule. VPA is looking for an AD to serve on the VPA Sports Medicine Advisory Committee. Looking at the ability to use 8th grade girls in Lacrosse and hockey. Currently 8th graders are not allowed in contact sports of wrestling, hockey, football and lacrosse. The feeling is that because girls hockey and lacrosse to not "officially" allow contact, then the use of 8th graders would be appropriate. This has to come forward as an official proposal. Individual participation limit in a day and a specific request coming from basketball has been made. They would like students to be able to participate in 5 quarters per day instead of 4. The proposal has the support of the VBCA and the VPA Sports Medicine Advisory Committee. Next move is to go to the VPA Basketball Committee and then on to ASC.

New Business/ Announcements

• Bass Fishing

- Schools interested in participating in bass fishing need to send me a letter stating your intent for joining the exhibition sport. This can be done via email or mail and must be written on your school letterhead.
- We have the support of VT Fish and Wildlife. They will also assist in determining lakes, ponds, and rivers for tournament or scrimmage sites.
- There are 5 to 6 VT clubs that are willing to help with tournaments and potentially captaining a boat.
- We would be joining VT BASS NATION The major club in VT Club membership is \$10 and then \$10 / athlete - Students would also need to get a VT fishing license
- o Can be a first sport or secondary sport
- o Follow the fall schedule.
- Have an exhibition 'championship tournament' to culminate the end of the season. There would only be a championship, no districts or qualifying rounds
- o Practices can be from the land or water
- Localized scrimmages can be fishing from land or water
- VT Fish and Wildlife has talked about holding workshops/clinics surrounding ecology, proper care and handling of fish, taking care of boats, etc.
- Utilizing the Let's Go Fishing program could possibly use as a fundraiser for our program
- As a Bass Fishing organization, we would purchase a Series Tournament Permit for \$50 and that would be good for the entire season.
- Policies and Procedures will be very similar to the NH side of Bass Fishing. Once I have all of the letters of intent, I will begin formally writing them.

• Member to Member Policy Change-

- Changed and/or to AND in the Rationale of what member to member is designed to do.
 This will help programs that are struggling and in need.
- Numbers for a full team is still there. Some numbers have changed.

- Once the student is in, they are in. Assured that they get to remain in the program once
 in. They will be grandfathered in, but they do have the option to go to a closer school if
 they wish.
- It is now specific to teams not programs.
- VSADA is going to review in March at their meeting and will come back to ASC in May for approval.
