Treasurer's Report

Sean Farrell

• Sean Farrell - We started today at about \$30,000, after paying for the conference today we are now under \$8,000. We had several overdrawn dues this year. We had scholarship winners that went to deposit their checks and they bounced, to be frank, this is embarrassing. We need to get our dues in on time. We can't afford this, we need to be better. We don't have the ability to leverage ourselves and business offices to turn things in. Please process your paperwork and get it done. Lets be better. We are at \$7,951.00 and we will have more expenses as the rest of the year goes on. It is also imperative that you talk to your business office about the vendor. The vendor has changed - Bob Hingston still got a check for this conference and he hasn't been here for five years. Every payment should be going to Sean as the treasurer for the VSADA. Please work with your business office.

VPA-SAAC Presentation

- Four members from the VPA SAAC presented on the athlete-coach relationship and how it can be improved.
- **Sean Farrell** Do you have any advice for us as athletic directors about how we can better help student-athlete retention and interest?
- **Students** We meet with Dan Marlow once a month in our captain's council. We talk about the good things that are happening along with the bad.
- We are growing up in a generation where a lot of students feel as though they are overwhelmed and everything is so demanding. Oftentimes school feels like a job, then we go to sports, and we are exhausted the next day. Any way to help students employ strategies to get their work done. Secretary & VP Open Positions Devin Wendel

- Devin Wendel Please consider applying for our two open positions. We have some incredible talent in

 is a great way to get involved and give back to the association and in turn our coaches and
 student-athletes.
- Geri Witalec-Krupa Please know that you aren't locked into an 8 year commitment, even though we would love to have that happen. We understand that life happens.

Executive Director's ReportJeff Goodrich

- **Jeff Goodrich** One of the things I have been working on is recruiting and retaining ADs in the state because it is such a vital role to our communities. The students that just presented are a great example of the work that grounds us. When we are all aligned and we are trying to do the same good work, hopefully we see a decline in phonecalls, litigations, and investigations. Your work today and time spent at this conference is a testament to your desire to grow both personally and professionally.
- I will put together a survey to help gather information about retention. There are people within our state and people outside of our state to help build our base and improve our retention. I don't believe the transition we saw last year with ADs was a one-off event, so we need to work hard to retain ADs, especially our new ADs.

NIAAA Liaison/Section 1 Report Geri Witalec-Krupa

• Geri Witalec-Krupa - The NIAAA would love to see more Vermont representation on the various NIAAA committees. Commitment on these committees could range from 2-4 years. Does require attendance at the National Conference every year. It also demonstrates the work that we bring to the table, we are small but we are mighty. If you are interested in applying, please email me and I will send you the national application.

- Soon, we are going to be launching the 'AD Hotline' it is going to be a portal through SportsYou that you can just ask the question you want to ask. It is very validating that we all know that we have resources around us. It can be anonymous as you want or as broad as you want. We plan to launch this relatively soon, it will be another support system for all of us. We are all experiencing the same thing across the country.
- The NIAAA Summer Institute will not be happening this summer. They were trying to find a new location, they had a few leads but those options fell through. For those of you who have attended, that conference set a high bar and they wanted to ensure they find a suitable replacement for the Ocean's Edge. Hopefully resuming next summer.
- Geri Witalec-Krupa Over the next two weeks, both of our scholar athletes will be passed on to the National level. The last section one winner was Dave Miceli's son. With the amount of turnover that we have, the student-athlete scholarship nominations are sought annually. We award these at the leadership conference every year, we select 10 applications every year. I am happy to help with this, we are looking to get a robust applicant pool started each year.

LTI/State Coordinator Report David Marlow

- CAA/CMAA Certification Guide
- **David Marlow** We taught four different classes at this year's conference, three of which were taught by Vermont ADs. We had some classes that were closest to 20 students for the first time in a while. It is a testament to the desire to learn within our organization and we thank you for that.
- Geri, Chris, Jake, Thank you for presenting. We have some very intellectual Athletic Directors within our organization that do a tremendous job with presentations. We are always looking for more instructors, if you're interested in becoming an instructor, you need to take LTC 790 and if we have interest, we can teach the class here in the future. There is now a practice test that you can take prior to taking your CAA. There are currently 24 active ADs that have their CAA, there are 7 current ADs that have their CMAA Certification. We have in our shared resource folder all of our past projects linked within the VSADA shared resource folder. If anyone is looking for ideas related to pursuing their CMAA this is a great thing to check out. Thank you all for your work with LTIs and your work to get better.
- **Devin Wendel** Dave, you can now take all the prerequisites online to sit for the CAA exam correct? (NIAAA Webinar/Online Course Link)
- David Marlow Yes
- **Jeff Goodrich** How many Licensed administrators are in the room? (show of hands) 6. These certifications can be very helpful in the event that litigation becomes part of your daily work. Being certified by the National Organization speaks volumes if you're ever in this situation. Because we have so few licensed administrators, this is the next most recognized level of certification that ADs should strive for.
- Sean Farrell When I got my CAA, I I was able to take that to my administration and got a slight bump in my salary. I am not a licensed administrator and their is no athletic director licensure in Vermont, so this is as close as you can get. Makes renewal process easy. If you're looking for a bargaining chip with your administration to negotiate your position, this is a great thing to have.

Leadership Conference

Dave Miceli

- Dave Miceli In regards to the leadership conference that we run in November, I believe that we have hit on a format that we like. We want students to present to students, we feel that is a powerful thing during the conference. One of the things we want is a speaker that addresses DEI and getting our athletic leaders focused on that topic. This does add a cost to the conference that hasn't been budgeted. This costs more per student than we budget per student. I don't think we want to charge more than the \$140/student, we don't want students to not access this because of the cost. We could look for endorsements/sponsorships to help raise funds to support the conference. We are looking for someone to help with this and/or take the lead on this.
- **Jeff Goodrich** How much do you think we would need to raise?
- **Sean Farrell** We need approximately \$6,000-\$8,000 to take the pressure off, and to ensure we are able to support a great conference.
- **Dan Marlow** I believe it is up to each of us to request from our own communities that we get additional funding from our local communities. If we work together, we can all make a difference instead of relying on one or two people to do the work.
- **Tim Messier** Are we a non-profit?
- Sean Farrell Not currently, but we can apply to be one.
- **Sean Farrell** Going back to the T-Shirts We didn't sell any t-shirts at the girls championships. The number of shirts we have at each venue has been based on what has been sold in the past. I do want to thank people that stepped up as many people stepped up and did multiple nights in multiple regions. It is also a lot of fun. We can't live on what we have for the rest of the year. I hear you that it is 'one more night' but if everyone gives up another night.
- **Jeff Goodrich** Pair off with a friend or a buddy. This is a great way to have some fun while supporting our organization.
- **Randy Rathburn** I brought my daughter to a game to sell 50/50 tickets and it has become a family tradition.

National Student Leadership Summit Dave Miceli

- **Dave Miceli** Every year I send out an application form. It is linked here. Please also take a moment to view the entire PowerPoint Presentation that was shared today. The NFHS Runs a 3 day summit for students from all over the country and Canada. There aren't a whole lot of students who have applied to go from Vermont. This really comes down to athletic directors to have the conversation with students to encourage them to apply. We ought to have more applicants for this summit.

NFHS Coach Education Report Dave Miceli

- **Dave Miceli** We talked about legal liability. We have so much exposure to litigation, please don't put out coaches who are not properly certified. If you have questions about what certifications are required please let me know. It is March 28th at the end of the first full week of April if coaches aren't certified I'll be sending out bills.
- David Marlow Any update on 3D coaching in lieu of NFHS Fundamentals Course
- **Dave Miceli** Yes <u>This 3D Course</u> (middle tier) is now an approved alternative to the NFHS course. 4.5 hours \$149 (non-college course credit).
- Sean Farrell Dave can you please share with us the difference between the two courses.
- **Dave Miceli** The 3D course is slightly shorter than the NFHS course. I believe it is the condensed version. The course itself uses a different approach to helping coaches understand the need to coach more than just Xs and Os, but the mind, body, and spirit together to be successful.
